**Minimum qualifications include:**

- U.S. Citizen with a valid driver's license.
- 21 years of age by March 24, 2018, and under the age of 35 at the time of final eligibility posting. This age limitation does not apply to current or previously employed full-time police officers or other exemptions as defined in Illinois Compiled Statutes 65 ILCS 5/10-2.1-6.
- Valid POWER test card due at orientation. Power test card is considered valid only if dated between March 24, 2017 and March 24, 2018. - Possess 60 college credit hours (official transcripts required at orientation).
- Residency within the Village of Lansing within six months after completion of the 12 month probationary period.
- Successful completion of all phases of testing process.
